The purpose, function, and nonprofit status of the organization (agency) and the exempt status for Federal income tax purposes has not changed during the preceding 12 months. The extent and nature of circulation is as follows: Total number of copies (A) (average number of copies of each issue during the preceding 12 months) was 2165 and the actual number of copies of the single issue published nearest to the filing date was 1928. Paid circulation (B) is handled by the U.S. Government Printing Office, Washington, DC 20402, and (C) the total number printed for their sales (mail subscriptions and individual sales) was 500 for both the average number of copies each issue during the preceding 12 months and the actual number of copies of the single issue published nearest to the filing date.
